Decree No. 961 Of The Year 2012

Minister of Industry and Foreign Trade

Having taking cognizance of Import and Export Law No. 118 of the year 1975;

The Executive Regulations implementing the provisions of Import and Export Law No. 118 of the year 1975 promulgated by the Ministerial Decree No. 770 of the year 2005;

The two Ministerial Decrees No. 626 and 660 of the year 2011 on the Amendment of Some Provisions of the Executive Regulations implementing the Provisions of Import and Export Law;

The correspondences of the Chamber of Textile Industries and Chamber of Leather Industry dated 19/11/2012;

The memorandum of the Foreign Trade Sector and General Organization for Export and Import Control (GOEIC) dated 20/11/2012;

DECIDED THE FOLLOWING:

(Article One)

Two new items shall be added to Annex (3) attached to the executive regulations implementing the provisions of the said Import and Export Law, as follows:

| S. No. | Name of Article | Import Conditions |

| 5 | Shoes, leather bags, outfits, garments, fixtures, carpets and floor coverings | Except for commodities imported for personnel and private use, imported consignments may be released, if their manufacturers are registered at the General Organization for Export and Import Control, as per the provisions of Article |

| | | (94) of the present regulations or upon the submission of an approved and certified review and inspection certificate, covering the particulars of the consignment as well as the results of inspection and test that indicate their compliance with the approved Egyptian standards, save as such certificate is issued from an ILAC-approved body or an Egyptian or foreign body which has approved laboratories, specialized in the tests required for each commodity, as approved by the Minister concerned with Foreign Trade. Such consignments shall be further subject to the General Organization for Export and Import Control random inspection. |
| 6 | Natural leather, artificial leather, shoes elements, textiles and dyed and colored yarns | Except for commodities imported for personnel and private use, such imported commodities may be released after the satisfaction of the conditions and procedures of control over imported commodities - stated in section two of these regulations - and after the payment of test costs. |

(Article Two)

The aforesaid two Ministerial Decrees No. 626 and 660 of the year 2011 shall be nullified. Any provision in contradiction to the provisions of the present Decree shall also be rendered null and void.

(Article Three)

The present Decree shall be published in Al-Wakaye Al-Mesreya / Government Bulletin and shall apply as of the day following its date of publication.
