









On sanitary measures and restrictions for certain types of food products imported into the territory of the Russian Federation

In order to ensure the safety of life and health of the population of the Russian Federation, the Federal Service for Supervision of Consumer Rights Protection and Human Wellbeing controls the circulation of hazardous food products, including those containing undeclared chemicals.

Rospotrebnadzor has built a vertically integrated system of supervision and laboratory control, which makes it possible to ensure effective control over the safety and quality of food products circulated on the consumer market.

For 9 months of 2021, according to the results of laboratory tests of food products for the content of pesticides conducted by the institutions of Rospotrebnadzor, in 16% of the total number of samples examined, residual amounts of pesticides were found that were not standardized by the technical regulations of the Customs Union, as well as that did not pass state registration on the territory of the Russian Federation.

In addition, Rospotrebnadzor receives information about similar violations through the Rapid Notification System for the Quality of Food and Feed of the European Union (RASFF).

In this regard, on the eve of the New Year holidays, Rospotrebnadzor strengthened control over the quality and safety of food products, including fruits and vegetables from Turkey, Egypt, China, Germany, Uganda, Ecuador, within which, over the period from October to November 2021, more than 7.5 thousand samples of food products for the content of chemical substances, including those unregistered on the territory of the Russian Federation.

As a result, for the period from 10/27/2021 to 12/07/2021, 6 types of agricultural food products (tangerines, lemons, grapes, pomegranates, peppers) well identified by 33 manufacturers from the Republic of Turkey and the Islamic Republic of Iran, which contained residual amounts of 12 pesticides, 10 of which the Russian Federation have not passed state registration and are not allowed for use in the Russian Federation; Concentrations of such pesticides a chlorpyrifos, acetamiprid, which are hazard class 2 substances, were more than 2 times higher in various types of food products.

It is important to note that for a child weighing 20 kilograms, the consumption of one medium tangerine containing chlorpyrifos can lead to an increase in the average daily dose by 2.5 times and the manifestation of toxic effects, and the use of grapes in which the detected concentration of acetamiprid exceeds the hygienic standard 2.4 times, taking into account the toxicological properties of acetamiprid, can cause acute poisoning of the body of both a child and an adu

The Federal Service for Supervision of Consumer Rights Protection and Human Welfare informs that in the documents accompanying imported products, the information on the name of active substances used in the cultivation of agricultural crops did not contain pesticides detected by Rospotrebnadzor, which is violation of the Decision of the Customs Union Commission of 28.05. 2010 № 299 "On the application of sanitary measures in the Eurasian Economic Union"

In connection with the above, Rospotrebnadzor suspended the import from the Republic of Turkey and the Islamic Republic of Iran to the territory of the Russian Federation of 33 producers of lemons, tangerines, peppers, grapes, pomegranates, and in connection with repeated violations from 17.11.2021 - the import of Turkish peppers and pomegranates origin, from 02.12.2021 - import of pepper of Iranian origin, from 10.12.2021 - import of grapes of Turkish origin. As a result of the measures taken, about 60 thousand tons of grapes and more than 10 thousand tons of pomegranates from Turkey were not allowed to be imported into the territory of the Russian Federation.

In addition, in October 2021, the import of 4 types of food products produced by the People's Republic of China was prohibited, in which DNA of genetically modified corn and soybeans was found in an amount of up to 20% with a standard of less than 0.9% (there was no information on their content on the product labeling).

Information on the introduced temporary sanitary measures in accordance with the international obligations of the Russian Federation for each fact was sent to the authorized bodies of the Republic of Turkey, Islamic Republic of Iran, China, EurAsE member states, as well as interested federal executive bodies of

Taking into account the persisting risks of importing products unsafe for public health into the territory of the Russian Federation, the possible expansion of the geography of supplies, including redirecting the flow of food products prohibited for import through third countries, as well as the use of new chemicals in the production of food products, including those unregistered in Russian Federation, Rospotrebnadzor continues to strengthen control over fruit and vegetable products.
