#### NOTIFICATION UNDER ARTICLE 12.1(A) OF THE AGREEMENT ON SAFEGUARDS ON INITIATION OF AN INVESTIGATION AND THE REASONS FOR IT

INDONESIA

Articles of Apparel and Clothing Accessories

The following communication, dated 1 October 2020, is being circulated at the request of the delegation of Indonesia.

Pursuant to Article 12.1(a) of the WTO Agreement on Safeguards, the Republic of Indonesia hereby wishes to notify the Committee on Safeguards that the Indonesian Safeguards Committee (*Komite Pengamanan Perdagangan Indonesia*/KPPI), hereinafter referred as "the Investigating Authority", has initiated a safeguard investigation on the imports of the product under investigation.\*

On 9 September 2020, an application for a safeguard measures was received by the Investigating Authority from Indonesia Textile Association (*Asosiasi Pertekstilan Indonesia*/API) hereinafter referred as "the Applicant", against importation of the product under investigation. After examining the properly documented application, the Investigating Authority concluded that there was a sufficient evidence to justify the initiation of a safeguard investigation.

## **1 THE DATE OF INITIATION OF SAFEGUARD INVESTIGATION**

The investigation initiated on 1 October 2020.

## **2 PRODUCT UNDER INVESTIGATION**

Articles of apparel and clothing accessories, under *Harmonized System* (HS.) codes 6101, 6102, 6103, 6104, 6105, 6106, 6109, 6110, 6111, 6117, 6201, 6202, 6203, 6204, 6205, 6206, 6209, and 6214.

## **3 REASONS FOR INITIATION OF INVESTIGATION PROCEDURE**

- a. The Investigating Authority initiated a safeguard investigation following an evaluation of the application documents filed by the Applicant, which constitutes a major proportion of the total domestic production of the subject goods in Indonesia.
