- have a great opportunity of face-to-face networking, meeting new partners and friends.

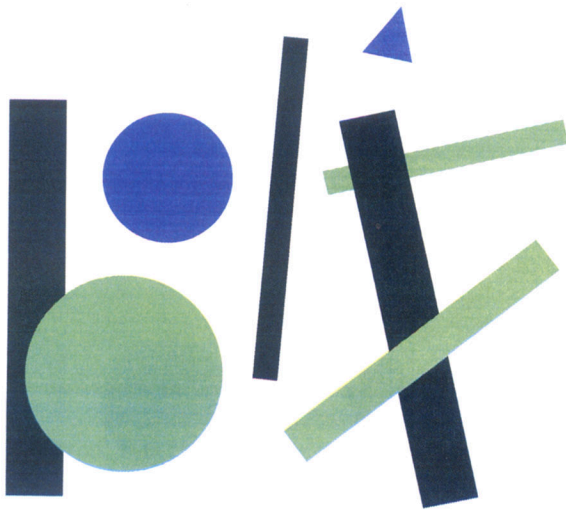

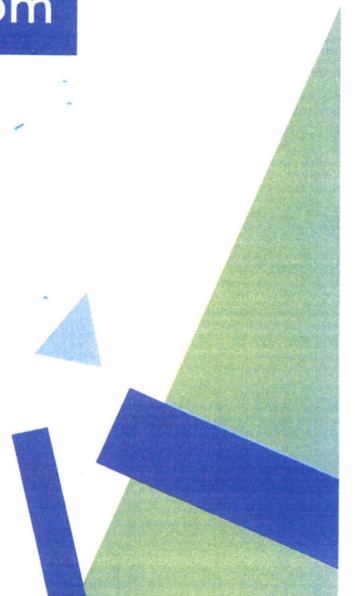

## The key topics of BIF are:

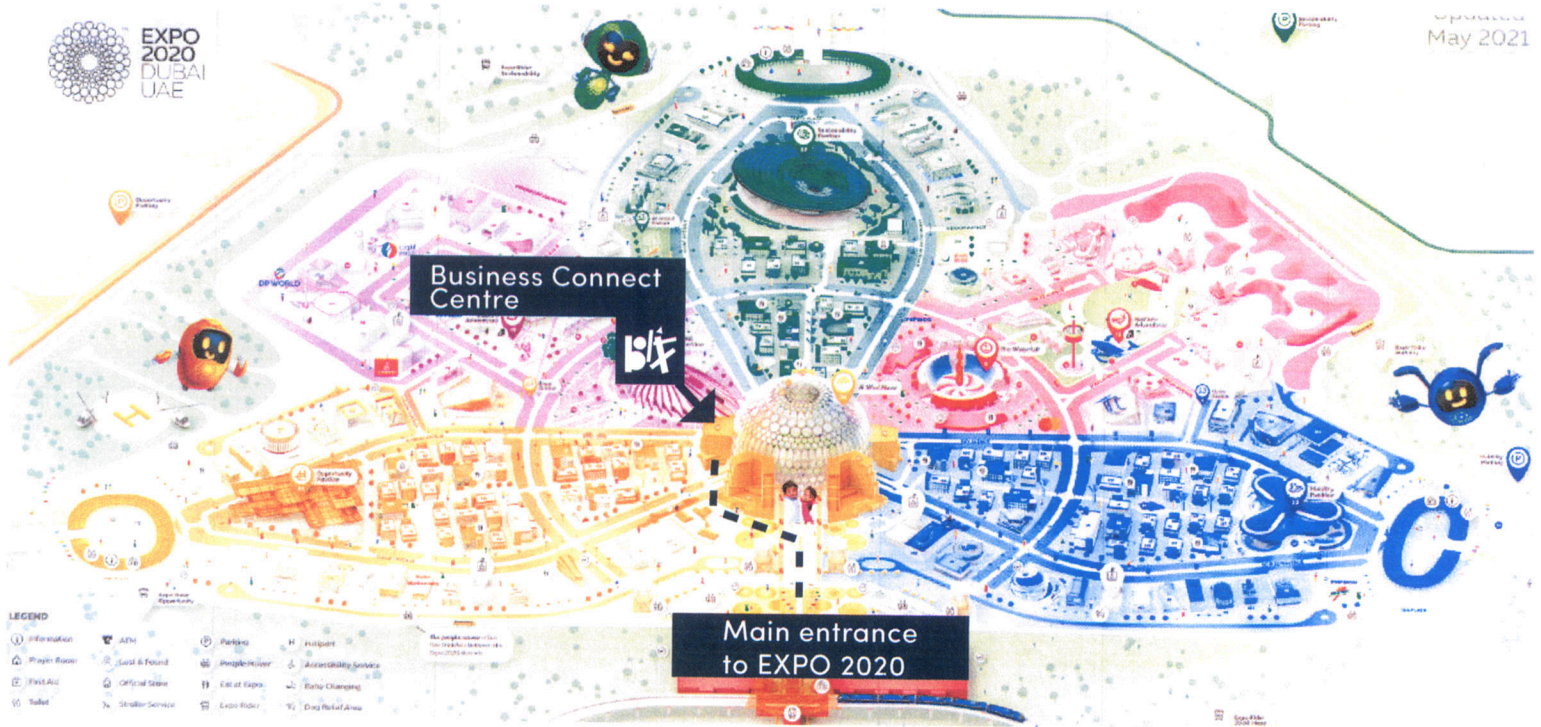
- Measures taken by the Government of the Republic of Belarus to stimulate business & investment activity;
