VIET NAM

(Diammonium Phosphate and Monoammonium Phosphate fertilizers)

The following communication, dated 9 March 2018, is being circulated at the request of the delegation of Viet Nam.

In accordance with Ordinance No. 42/2002/PL-UBTVQH10 dated 25 May 2002 of the Standing Committee of the National Assembly on Safeguards on Imports of Foreign Goods into Viet Nam and Decree No. 150/2003/ND-CP dated 8 December 2003 of the Government providing detailed regulations for implementation of Ordinance on safeguards on imports of foreign goods into Viet Nam, the Ministry of Industry and Trade notifies the application of safeguard measures on the imports of "certain fertilizers of Diammonium Phosphate (DAP) and Monoammonium Phosphate (MAP)" under HS code 3105.10.20; 3105.10.90; 3105.20.00; 3105.30.00; 3105.40.00; 3105.51.00; 3105.59.00; 3105.90.00.

1. Background

On 12 May 2017, the Ministry of Industry and Trade issued the Decision No. 1682A/QD-BCT on the initiation of safeguard investigation on certain fertilizers of DAP and MAP (hereinafter referred to as "subject products") imported from various countries.

On 4 August 2017, the Ministry of Industry and Trade issued the Decision No. 3044/QD-BCT on the application of provisional safeguard measures on subject products imported from various countries.

2. Subject product

The fertilizers under the investigation included: DAP and MAP containing substantial elements of Nitrogen and Phosphorus with minimum content of 7% Nitrogen and 30% Phosphorus.

Certain DAP and MAP products under HS Code: 3105.10.20; 3105.10.90; 3105.20.00; 3105.30.00; 3105.40.00; 3105.51.00; 3105.59.00; 3105.90.00.

Fertilizers are excluded from scope of subject products having one of the elements as follows: N < 7%; P₂O₅ < 30%; K₂O > 3%.

3. Safeguard measures applied

The Ministry of Industry and Trade shall apply safeguard measure in the form of additional import duty on subject products imported into Viet Nam as follows:

07/03/2019–06/03/2020	VND 1.072.104 per ton

4. Countries or origin of products under investigation subject to safeguard measure

Safeguard measure is applied to imported products from all countries under investigation, except for countries excluded from the investigation in accordance with the regulation on negligible volume of imports (Article 13 of Decree 150/2003/ND-CP of 8 December 2003 detailing regulations for implementation of Ordinance on safeguards on imports of foreign goods into Viet Nam). Please see the list of countries excluded from the investigation in the Appendix below.

5. Effective date of the safeguard measures

Safeguard measures will take effect from **7 March 2018**.

6. Basis for application of the safeguard measures

Based on the information provided by interested parties, the Investigating Authority determines as follows:

- The volume of subject products imported into Viet Nam increased in both relative and absolute terms.
- There is a price depression and price suppression of subject products against the like products produced domestically.
- The domestic industry has suffered serious injury in terms of: output, capacity, turnover, utilization capacity, profit, market share, inventories, labor and the volume of domestic sales in the period of 2013–2016.
- The domestic industry has faced with negative equity and may have to stop production if the loss continues in 2017.
- The increase of import of subject products has caused serious injury to the domestic industry.
