土耳其共和国驻华大使馆:

4月7日,联合国粮农组织和世界卫生组织发布了《新冠肺炎和食品安全:对食品企业指南》,对当前新冠肺炎流行的情况下,有效防止病毒污染食品,避免影响食品安全,将发挥重要作用。中方已将该指南翻译成中文,并制作了视频教材发给中国出口企业,请企业自觉按指南要求组织生产,防范病毒污染。我们希望贵国输华食品的生产企业能自觉按照该指南要求,建立有效的食品安全管理体系,做好各项预防措施,确保输华食品未被新冠病毒污染。我们也希望一旦输华食品企业发现新冠肺炎病例/疑似病例,或输华食品存在被污染风险,贵方应主动暂停相关企业对华出口,及时向中方通报存在风险的相关企业内部发生新冠肺炎疫情情况及其输华食品信息,待确认已消除相关风险后再恢复出口。

中方持开放合作的态度,欢迎贵国安全优质的食品输华。请 贵馆将中方上述意见转达贵方食品安全主管部门,并期待着与其 进一步合作。

Letter from the Import and Export Food Safety Bureau of the General Administration of Customs on ensuring the safety of food exported to China

Embassy of the Republic of Turkey,

On 7 April, the UN Food and Agriculture Organization and the World Health Organization released the COVID-19 and Food Safety: A Guide for Food Enterprises, which will play an important role in effectively preventing the virus from contaminating food and affecting food safety in the current situation of the COVID-19 epidemic. The Chinese side has translated the guidelines into Chinese and produced video teaching materials for Chinese export enterprises, which are requested to organize production according to the guidelines to prevent pollution from virus. We hope that Turkish manufacturers of food products exported to China will consciously establish an effective food safety management system in accordance with the requirements of the guideline and take various preventive measures to ensure that food products exported to China will not be contaminated by novel Coronavirus. We also hope that once the food exported enterprises find COVID - 19 cases/suspected cases, or potential risk of exported food being contaminated, the Turkish side should take the initiative to suspend the export of the relevant enterprise and timely communicate with the Chinese side about the COVID - 19 outbreak happening within the enterprise and the information of its exported food to China. Export shall resume after confirming that the related risks have been eliminated

China welcomes safe and high-quality food from Turkey with an open and cooperative attitude. Please convey the above information to your food safety authority and we look forward to further cooperation with them.
